Minutes of the Business Meeting

The MSAPMS Annual Business Meeting was held in Mobile, Alabama on October 6, 2004. President Eric Barkemeyer called the meeting to order at 11:15 a.m.

Membership Report. There are 215 individuals on the member list. Of these, 55 are currently active members. Attending the meeting were 13 corporate sponsors, 1 vendor, 38 pre-registration delegates, 13 on-site registration delegates, and 4 students.

Financial Report. Renee Beam presented the financial statement as of October 1, 2004. MSAPMS has accounts at two different banks, one with Compass Bank and one with Peoples Bank. The reason there are two accounts is that the Peoples Bank account pays a high interest rate, but only allows four checks per year. So an account was kept at Compass Bank, which pays a lower rate but allows unlimited checks. To conduct the annual meeting several checks are needed to cover expenses. After the meeting checks clear, the remaining balance in the Compass Bank account will be transferred to the Peoples Bank account to take advantage of the higher interest rate. The balance in the Compass Bank account was \$6,072.80 prior to the meeting. The operational account balance at Peoples Bank was \$6,497.06, this account earned \$74.69 in interest as of February 14, 2004. The Alabama Power Scholarship fund earned \$123.37 as of February 14, 2004 bringing this year's balance to \$10,620.68. The MSAPMS Scholarship account had earned \$414.57 interest as of February 14, 2004 bringing this year's balance to \$32,062.32. As of October 1, 2004 last year's scholarship recipient check had not cleared the bank. The scholarship recipient was contacted and indicated that she had not received the check. It was either lost in the mail or due to her relocation the Post Office was unable to locate her. A check has been reissued. Currently the interest earned from both the scholarship funds is able to cover roughly half of the \$1,500.00 annual scholarship awarded by the MSAPMS. This brings the MSAPMS total assets to \$55,252.86. During the annual meeting a total of 621 raffle tickets were sold.

Newsletter/Editor Report. Bob Gunkel reported that three newsletters are published annually. The newsletter is distributed via e-mail and is available on the MSAPMS Website. If you are not receiving the newsletter via e-mail, please contact the MSAPMS Secretary with your correct e-mail address.

Scholarship Committee Report. There was only one application for the scholarship this past year.

Discussion was opened to the floor. There was no discussion and the membership recommended the board accept the nomination and make the award. If anyone knows of a candidate for the upcoming year, please contact Dr. David Bayne.

Website Discussion. Eric Barkemeyer stated that David Cline was unable to stay and give his report. Before his departure David agreed to continue to fill the roll of webmaster for the society. Eric asked the Website Committee to be more aggressive in helping David design the website for better content.

Nomination Committee Report. Tom Broadwell headed up this year's Nomination Committee and wanted to thank the Board of Directors that volunteered to continue to serve on next year's Board of Directors.

This year's slate included: President Elect Craig Aguillard, Secretary David Brewster, Treasurer Greg Wall, Editor Bob Gunkel, and Directors Bryan Goldsby and Don Morgan.

The floor was opened for additional nominations or discussion. There were no additional nominations from the floor. A motion was made to accept the slate of nominations, the motion was seconded, and passed by voice vote.

Old Business. There was no old business to discuss.

New Business. During the meeting, the Treasurer's files were reviewed by Tom Broadwell and David Brewster and found to be in good order. A motion was made to accept the financial statement, the motion was seconded, and accepted by voice vote.

Awards. During the awards luncheon, Joe Jernigan presented Directors Greg Wall and Mike Maceina with certificates of appreciation. Out-going President Eric Barkemeyer was presented with a plaque and Eric was thanked for his dedication.

- 3. A copy of the research proposal.
- 4. Two letters of recommendation (other than the major professor).

Graduate Assistantship Announcement

A graduate assistantship in the area of aquatic plant management and ecology is being offered by the Aquatic Plant Management Society (APMS) and the Aquatic Ecosystem Restoration Foundation (AERF). Co-sponsors of this academic award include six regional APMS chapters: Florida, Midsouth, Midwest, South Carolina, Texas, and Western.

Objective. To provide a stipend for a full-time graduate student to conduct research in the areas involving the various aquatic plant management techniques (used alone or integrated with other management approaches) or in aquatic ecology related to the management of regionally or nationally recognized nuisance vegetation.

Applicants. Solicitation for proposals is open to any full-time faculty member and/or graduate student of an accredited United States academic institution. A faculty sponsor must be identified if the application is submitted by a graduate student.

Amount and Duration. \$60,000, Two years


Proposal Deadline. Applications must be postmarked no later than April 30, 2005.

Guidelines for Proposals. Proposals should contain a concise statement of the project, including its purpose and justification, as well as sections that discuss study objectives, methodologies, schedule, budget, and planned publication of results. The APMS will not pay overhead/indirect costs on approved projects. Resume of faculty applicant and graduate student (if known), not to exceed two (2) pages each. Proposals should not exceed 10 pages, and must be signed by the applicant (principal investigator) and appropriate university official. An original and 10 copies should be submitted to: Mr. Donald W. Doggett, Lee County Hyacinth Control District, P.O. Box 60005, Fort Myers, FL 33906.

Award. Notification of award will be provided to the faculty member by July 2005, with initiation of the stipend scheduled for the 2005-2006 academic year.
