

Impacts of Aquathol K Applications on Largemouth Bass Spawning Behavior and Production of Young Fish

The first year of a two year project that examined the effects of direct spraying of Aquathol K on nesting largemouth bass in small ponds was completed. Aquathol K was applied at the approved rate of 3 ppm in three 0.1 hectare ponds in March 2005 as largemouth bass initiated spawning. Water was applied in a similar fashion to three other 0.1 hectare ponds. Aquathol K did not impact largemouth bass nesting activity; spawning behavior and activity was similar to ponds treated with water. Production and growth of young largemouth bass measured after spawning ended was similar between ponds treated with Aquathol K and control ponds.



Minutes of the Business Meeting

The MSAPMS Annual Business Meeting was held in Grand Casino & Resort; Tunica, Mississippi, on October 12, 2005. The meeting was called to order at 4:00 pm by President Joe Jernigan.

Secretary Report: Minutes from the 2005 Initial Board Meeting were summarized by David Brewster. Hard copies will be provided to members upon request to the secretary. A motion was made to accept the minutes, the motion was seconded, and the minutes were accepted unanimously by voice vote.

Membership Report: There are 240 past and present members on the membership list. Of these, 79 are currently active members. The past/present membership list was purged to include both active and past members since 2001 to present; this brings the list to 92 past/present members.

Financial Report: Greg Wall presented the financial statement as of October 5, 2004. MSAPMS Operational account \$15,560.08

Renee Beam and Tom Broadwell audited the books and found everything to be in good working order. A motion was made to accept the financial report as read. The motion was seconded and accepted by voice vote.

Newsletter/Editors Report: Bob Gunkel reported that this is his last year as editor for the Society. During 2005, three newsletters (January, May, and September) were distributed electronically. The members were reminded to be thinking of items to publish in our upcoming newsletters and to submit them to the editor.

Scholarship Report: There were two applicants for the 2005 scholarship. The Scholarship Committee presented a letter to the Board of Directors stating that both applicants met all of the requirements outlined in our "Operating Procedures". It was a unanimous decision of the Committee that both applicants were qualified and worthy of the scholarship.

The Board presented a recommendation to the general membership to changing the scholarship application due dates from October 31 to March 15, and to change the review board time from November 15 to June 1. A motion was made to make the recommended date changes for both scholarship and review board, and the motion was seconded and accepted unanimously by voice vote.

Nominating Committee Report: Eric Barkemeyer recognized Renee Beam and Don Morgan for their outstanding contribution and dedication to the Society during 2004.

9th Circuit Court of Appeals Rules on **Pesticide Application**

The 9th Circuit Court of Appeals, covering CA, OR, WA, NV, ID AK and HI, recently overturned its previous decision to require NPDES permits under the Clean Water Act when applying pesticides to aquatic areas. In a new suit, the court relied on the EPA's recent statement that a properly and intentionally applied pesticide cannot be considered a "pollutant" and therefore does not require a special permit under the CWA. Compliance with FIFRA labeling requirements will be sufficient for aquatic applications in the 9th Circuit.

The most relevant portion of the opinion states:

"Pesticides that are applied to water for a beneficial purpose and in compliance with FIFRA, and that produce no residue or unintended effects, are not 'chemical wastes,' and thus are not 'pollutants' regulated by the CWA. Because intentionally applied and properly performing pesticides are not 'pollutants,' a potential discharger is not required to secure a NPDES permit for such pesticides before discharge."
